The vehicle will be available for inspection between 2.00 PM to 3.00 PM upto 17.06.2011.


3. The quotations received in time will be opened in Room No.526-A, Shastri Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at time of opening of quotations.

4. The sale will be governed by the following conditions:

- (i) The bidder is required to pay Earnest Money of Rs.5000/- for this vehicle.

- (ii) Earnest Money is payable by means of Demand Draft drawn in favour of Pay and Accounts Officer, Ministry of Corporate Affairs, New Delhi. (payment by cheque or cash shall not be accepted).
- (iii) Quotations received without demand draft towards Earnest Money will not be considered and shall not be accepted.
